

CONDITIONS

Based on minimum 30 passengers

PRICE INCLUDES:

AIR TICKET: On economy class. All air tariffs are subject to change and Governmental regulations. **Once purchased, airline tickets cannot be changed or refunded.**

INSURANCE: Medical Insurance

HOTELS/CRUISE: Superior 4 star, 2 persons sharing twin with private bath.

MEALS: Two meals per day: (buffet) **breakfast** and **dinner**

EXCURSIONS: Air conditioned motorcoach and English speaking guide. Entrance fees are included according to the program.

PORTERAGE: One medium size suitcase per person.

TAXES: All taxes of Hotels and flights/Pier.

NOT INCLUDED ON PRICE: Luggage Surcharges which may be imposed by airlines and other suppliers. If applicable, luggage surcharge will be paid by the passenger; **T**ips for guides and drivers (\$ 5,00 per person per day). **C**ost to obtain a passport, Visa; **T**ravel Protection Program; **P**ersonal expenses like drinks, telephone calls, laundry, **S**upplement per night for single room (if requested), etc.

RESERVATION: A full deposit of **\$ 300 (not refundable)** per person to make reservation.

FINAL PAYMENT / DEADLINE: should be done: **45 DAYS PRIOR DEPARTURE** .

PENALTIES / CHARGES:

a) \$ 100.00 supplement per Person if payment is received within 7 days after the deadline

b) \$ 200.00 supplement per Person if payment is received within 8 to 14 days after the deadline

c) \$ 300.00 supplement per Person if payment is received within 15 to 21 days after the deadline

d) CHANGE or NEW NAME received after the deadline is subject to a surcharge between **\$ 100.00** and **\$ 400.00** p.p.

CANCELLACION POLICY: In case of cancellation will be applied following penalties: From reservation until **45 days before** departure \$300 per person - From **45 to 31 days before** departure:20% of the cost of the excursion. From **30 days until 15 days before** departure: 50 % of the cost of the excursion. **14 days until the departure day:** 100 % of the cost of the excursion.
